ONE YEAR LIMITED WARRANTY

Smart Showers steam shower, steam shower whirlpool tub units and Smart Panel™ shower panels are warranted to the original consumer purchaser to be free of manufacturing defects in material and workmanship during normal residential usage for one year from the date of purchase. This warranty applies only for Smart Showers steam shower, steam shower whirlpool tub and Smart Panel™ shower panel units installed in the United States of America, Canada and Mexico.

Finished material surfaces are warranted for one year. Finished material surfaces are the acrylic-fiberglass and tempered glass or stainless steel and tempered glass that are visible when the unit is placed in its intended operational place.

If a defect is found in normal residential use, Smart Showers™ will, at its election, repair or replace the unit, or make appropriate adjustment. Damage caused by improper installation including final assembly, accident, misuse, or abuse is not covered by this warranty. Gloss reduction, scratching, staining and alkaline etching, of the finish over time due to use, cleaning practices or water or atmospheric conditions are not manufacturing defects but are indicative of normal wear and tear. Proof of purchase (original sales receipt) must be provided to Smart Showers with all warranty claims. Smart Showers is not responsible for labor charges, removal charges, installation, or other consequential costs other than those noted above. In no event shall the liability of Smart Showers exceed the purchase price of the unit. This warranty is not applicable for commercial installations.

This limited warranty is void if:

- the installation, plumbing and wiring is not performed by certified and licensed professionals or authorized qualified service representatives;
- the equipment has been altered or repair has been attempted by any person other than an authorized qualified service representative.

A return authorization number assigned by Smart Showers is required prior to returning any product for repair. Components returned without a return authorization number will not be repaired or replaced. Shipment of any defective part or unit to and from Smart Showers shall be solely at the expense of the customer.
